## Participants Indemnity and Waiver

### Risk Warning

The Snake River Paint Horse Club of Idaho advises that the participation, including passive participation, in events or activities at the Ranch Horse Spectacular show contains elements of risk, both obvious and inherent. The risks involved may result in property damage and/or personal injury including death.

I understand that engaging in equine activities come with risk, including but not limited to certain inherent risks of equine activities, or those dangers or conditions which are an integral part of this equine activity.

By entering into this agreement, the exhibitor assumes the responsibility for the cow that the exhibitor draws and works in the class. If at any time the exhibitor continues to work the cow, places the cow in harm, causes undue stress on the cow, the exhibitor will be held responsible for the replacement (loss) cost of said cow, whether the cow dies or is injured because of the exhibitor's neglect. Neglect can be exhibited as working the cow after the judge has excused the exhibitor from the cow, running cow into the fence, running cow into the ground while working the cow, running over the cow, collision with other animals or objects. This includes the loss of the cow after the cow is in its pen (corral), and it was noted that the cow died or had been injured due to neglect in the show pen by the exhibitor.

Exhibitor understands that the SRPHC has provided the exhibitor with well (healthy) cattle, free of disease or injury and the fee is \$80 dollars per run and/or \$110 dollars per run for cutting cattle. Late cattle reservations fee of \$35 per head.

I HAVE CAREFULLY READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, AND FULLY UNDERSTAND ITS TERMS, AND I HAVE SIGNED IT FREELY AND VOLUNTARILY. I HAVE HAD ADEQUATE TIME TO READ AND UNDERSTAND THE AGREEMENT, AND THAT MY SIGNATURE IS A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE SNAKE RIVER PAINT HORSE CLUB, ITS MEMBERS, DIRECTORS, OFFICERS, HIRED HELP AND VOLUNTEERS.
