

Snake River Paint Horse Club All Breed Ranch Horse Futurity 2018

Rules & Regulations

The SIRE of a foal must be Nominated with the SRPHC Ranch Horse Futurity according to the following rules and regulations before said foals are considered eligible for entry in any of the Ranch Horse Futurities

Credit Cards will be accepted over the phone and a processing fee will apply to Credit Card Transactions

1) STALLION LISTINGS

A- Stallion nomination fee of \$150 must be paid by February 1st of the show year and will be designated as a Nominating fee, March 1st through March 31st \$225, April 1st through the Futurity entry date June 1, \$350. All Stallions must be nominated each year.

**For the 2018 season, all Stallion Nomination late fees will be assessed. **

B- All stallions nominated and/or Stallion Service donated makes all offspring eligible to compete in that year.

C- Stallion owners can choose to NOT pay the nomination fee **IF** they donate a stallion service to the annual service auction. If the stallion service does NOT sell, Stallion nomination fee must still be paid for offspring to be eligible for the futurity. Stallion owners who donate a service and the service sells, will receive **ONE** free entry into any **ONE** futurity class and said class must be declared by the first payment due date of June 1st.

D- The nomination fee can be paid any time PRIOR to the Futurity entry closing date for which the foal would be eligible to participate in. Late penalties will be assessed.

E- If a stallion is leased, the lease agreement must be approved and on file with the respective registration association and a copy of such agreement must be forward to SRPHC President.

F- The stallion nomination fee may be paid by the stallion owner/lessee or by another person. Permission must be provided in writing if it is to be someone other than the owner/lessee except: if the stallion owner fails to respond to other interested parties upon inquiring to nominate. With notification to the SRPHC President and/or Ranch Horse chairman, SRPHC will attempt to contact said owner of Stallion wishing to be nominated. At that time the SRPHC will send a certified letter to the owner/lessee with request for listing, if owner cannot be found, or if there is no reply to this nominating request within ten (10) working days, the other parties have until February 1st of the nominating year to pay the stallion nomination fee of \$150, March 1st through March 31st \$225, April 1st through the Futurity entry date \$350.

G- Once the stallion has been nominated, the resulting offspring is eligible to be in one, or all of the following listed futurities:

- Yearling Ranch Halter Futurity (Colts, Geldings, Fillies)
- Yearling Ranch In-Hand Trail
- 2 Year Old Ranch Halter (Colts, Geldings, Fillies)
- 2 Year Old Ranch In-Hand Trail
- 2 Year Old Ranch Pleasure *no cross over from In Hand classes*

- 2 Year Old Ranch Trail *no cross over from In Hand Classes*
- 3 Year Old Ranch Halter (Stallions, Geldings, Mares)
- 3 Year Old Ranch Pleasure
- 3 Year Old Ranch Trail ○ 3 Year Old Ranch Riding
- 3 Year Old Ranch Cow Horse (does not include cattle charges)
- 3 Year Old Ranch Reining

*All-Around High Point 3-Year-Old, must show in 5 of the 6 classes offered, \$50.00 of each class entry fee will be added to the all-around pay out.

- 4/5-Year-Old Ranch Halter (Stallions, Geldings, Mares)
- 4/5-Year-Old Ranch Trail
- 4/5-Year-Old Ranch Pleasure
- 4/5-Year-Old Ranch Riding
- 4/5-Year-Old Ranch Reining
- 4/5-Year-Old Ranch Cow Horse (does not include cattle charges)

*All-Around High Point 4/5-Year-Old, must show in 5 of the 6 classes offered, \$50.00 of each class entry fee will be added to the all-around pay out.

- 6 Year Old+ Ranch Halter (Stallions, Geldings, Mares)
- 6 Year Old+ Maturity Ranch Trail
- 6 Year Old+ Maturity Ranch Pleasure
- 6 Year Old+ Maturity Ranch Riding
- 6 Year Old+ Maturity Ranch Reining
- 6 Year Old+ Maturity Ranch Cow Horse (does not include cattle charges)

*All-Around High Point 6-Year-Old+, must show in the 5 of the 6 classes offered, \$50.00 of each class entry fee will be added to the all-around pay out. **H-** Of importance to note is the fact that an eligible foal is not required to show in a subsequent futurity to remain eligible for any of the remaining futurities; i.e., if you do not wish to show the foal in the halter futurities, you need pay no additional sustaining fee to remain eligible for the riding futurities. **I-** Any foal from any stallion can compete in respective classes with fees paid prior to competing.

2) THERE WILL BE NO REFUNDS OF ANY FEES PAID TO THE SRPHC-RHF.

A- Stallions that have died, been gelded, or are no longer serviceable can still be nominated, in order for any get to be qualified to compete in the futurities.

3) Futurity Entry Fees: All regular and non-pro classes are \$150 which includes office and drug fee.

- Futurity entry fees will be divided into three (3) payments.
The payment schedule will be
1st Payment: \$50.00 Due June 1st
2nd Payment: \$50.00 Due July 1st
3rd Payment: \$50.00 Due August 1st

All fees double if late, postmark will determine date.

- Entry fees may be paid at any time prior to the due dates. After the due dates, fees will be doubled. Postmark of envelope will be the determining factor as to whether payment is late.
- 4)** Owners and or exhibitors will be responsible for entering the eligible horse in the correct futurity class.
 - 5)** An entry must be exhibited in all go-rounds of their respective futurity to be eligible to receive payback monies.
 - 6)** The SRPHC Futurity office will be open prior to each futurity for issuing numbers, checking papers and accepting late entries. However, the SRPHC Futurity office will CLOSE two (2) hours prior to the beginning of each futurity division. After this closure, there will be no further entries taken or numbers issued. NO EXCEPTIONS
 - 7)** A tie breaking judge will be picked before the start of each futurity to determine the distribution of awards only. Monies will be split evenly in the case of ties.
 - 8)** Insufficient checks will result in automatic disqualifications. This rule is strictly enforced.
 - 9)** It will be mandatory for each person earning money to give their Social Security Number to the SRPHC office before any prize money will be issued.
 - 10)** Prize monies will be paid to the current owner or the person paying sustaining entry fees of each entry.
 - 11)** All Futurity/Maturities will be judged by 2 or more judges with these judges being selected from current APHA, AQHA or ASHA judges' lists, and all scores being used to determine the winner. In the event of a tie score, one judges score will be used as the tiebreaker with the tie-breaking judge selected prior to the Futurity.
 - 12)** Registration certification or verification of pending registration from respective associations, or copies thereof, must be sent in with the first-class entry, and be presented to the SRPHC secretaries prior to the start of their respective futurity and will be used for identification purposes. Papers will be checked and must match the horse being exhibited. Prize monies will be held until registration certificate or copy thereof is provided to SRPHC office.
 - 13)** In each and every futurity, the horses will be placed from first (1st) to eleventh (11th) place and each horse will receive points according to the position in which it is placed. Point system will be as follows:
 - 1st Place-11pts
 - 2nd Place- 10pts
 - 3rd Place- 9pts
 - 4th Place- 8pts
 - 5th Place- 7pts
 - 6th Place- 6pts
 - 7th Place- 5pts
 - 8th Place- 4pts
 - 9th Place- 3pts
 - 10th Place- 2pts
 - 11th Place- 1pt

- 14)** Payoffs for the Snake River Paint Horse Club Ranch Horse Futurity and Stallion Owners Purse will be as follows

- 15)** Payback will be based on the number of entries in the show ring for the first go round. Futurity purses will be paid 30 days after each futurity.
- 16)** By entering this futurity, owners and handlers acknowledge the right and give permission to the managers of the futurity to do drug testing on any or all entries, randomly or in any manner decided upon by the management and to take appropriate action. (APHA Rule Book guidelines will be used).
- 17)** Any complaints must be presented to the SRPHC-RHF Board of Directors in writing. All decisions made by the board are final. Verbal abuse and unsportsmanlike conduct will not be tolerated, and exhibitors and/or owners may be disqualified and monies and awards forfeited. Respective association will be notified by letter regarding the incident. In these cases, there will be NO refund of entries paid and exhibitor and/or owner loses the right to claim for damages. Any incidents not covered by this rule will follow the current APHA rulebook.
- 18)** By entering this futurity, owners and handlers acknowledge the right of the managers of the futurity to recognize animal abuse and/or mistreatment and to take appropriate action.
- 19)** Violations found of rule 17, 18, and 19 will result in disciplinary action by the SRPHC Board of Directors, to include disqualification, fines and/or suspension from future SRPHC futurities. Additionally, all paid entry fees will be forfeited.
- 20)** Any person on suspension from APHA, AQHA or ASHA is not eligible to exhibit in any SRPHC futurity.
- 21)** The SRPHC reserves the right to refuse, accept conditionally or cancel any entry. SRPHC may also disqualify or prohibit exhibitors of entries without claims for damages. SRPHC also reserves the right to revise the rules and regulations at any time.
- 22)** The SRPHC will in no case be responsible for any loss, damage, or injury to horses exhibited; for any article of any kind or nature that may be lost, stolen, destroyed, or in any way injured. Each exhibitor will be solely responsible for any consequential or other loss, injury, or damage done to, or occasioned by, or arising from any horses or article owner or exhibited by him, and shall indemnify the SRPHC against all legal or other proceedings, claims, or demands of any kind of nature in regard thereto, or that may arise from negligence of the person in charge of any such horse or article
